 6. Medical Control is not required and not available
 7. No dosing or route required for med admin
 - g. Candidate Expectations Include:
 1. Adjust O2 admin based on pt
 2. Determine hypoglycemia with AMS
 3. Treat for shock
 4. Ventilate a trauma pt with a closed head injury and signs of herniation to maintain EtCO₂ 35-45 (EMT)
 5. Dry sterile gauze for burns
 6. Seal sucking chest wound
 7. Obtain 12 lead
 - h. Same day retest policy
 - i. Staffing to reflect number of Candidates
