Staff Report	Background and purpose of Committee.  M. Player explained the rationale behind Peninsulas Emergency Medical Services Council, Inc. Board of Directors' desire to establish a PEMS Interfacility and Critical Care Transport Committee. He explained that the Board had noted that over a third of the licensed EMS agencies located in the PEMS service area provided emergency medical services as inter-facility and critical care transport agencies and not as Designated		

	Emergency Response Agencies (DERAs). They recognized that the Interfacility and critical care transport agencies were not represented on committees and their issues were not generally represented in regional EMS delivery and patient care discussions. The Board felt that the time had come to fully enfranchise these agencies and to include their important voice in the work of the Council, especially noting that Interfacility and critical care transports are becoming more frequent as the specialization of health care delivery continues to change.  M. Player made two presentations (attached). One demonstrating how paradigms through the PEMS Interfacility and Critical Care Transport Committee.  PEMS Council Overview – Tabled by consensus.

New Business	M. Player initiated a discussion on Committee Direction and Issues with those in attendance. It was quickly determined that the Council needed to reconnect with the identified Interfacility and critical care transport agency representatives and attempt to set up another meeting to establish this new initiative. It was suggested that M. Player provide those in attendance with the list of agency representatives in order to help facilitate attendance at the next scheduled meeting. M. Player stated that he had hoped the committee would meet at least quarterly. Those in attendance stated that they did not wish to wait three months for the next meeting. A tentative date of January 24, 2017 was set for the next meeting.  D. Baylous stated that she would like to demonstrate the committee's value by identifying some initial issues that the committee could begin to address. Those in attendance discussed several issues, including: the definition of critical care transport, helicopter EMS safety and the lack of consistency in patient turnover. They ultimately decided to concentrate the committee's initial efforts on the lack of consistency in patient turnovers/transfers. B. Harris and D. Wilson both offered to bring their patient turnover/transfer checklist with them to the next meeting with the idea that the committee might develop a regional patient turnover/transfer standard procedure and patient care transport (turnover/transfer) sheet that could be used by all agencies to improve the quality of patient turnovers/transfers.  D. Wilson asked M Player if he could research the State of Virginia's definition of critical care transport for the next meeting. M. Player agreed. He stated that he would also attempt to have Michael Berg, Director of Compliance for the Virginia Office of Emergency Medical Services or Wayne Berry, the Regional Representative for the Virginia Office of Emergency Medical Services to attend/call into the next meeting in order to answer questions on regulations and current issues impacting inter-facil
