Note – this was incorrectly identified as September during the meeting.</p> <p>Missing PPCR Data – T. Mitchell reports that the Virginia Hospital Hub only reports minimum data set. He also addressed the issue of PPCRs not making it into the hospital health record. Both missing reports and missing updates were addressed. It was noted by J. Laing that part of the problem is that amendments to a report are never received by the hospital as the hospital doesn't have access. There was much discussion regarding this issue with no proposed resolution. It was noted that ePCRs can be pushed to EPIC, but must be paid for by the hospital systems, be even this wouldn't solve the problem with multiple platforms.</p>
