New Business	Regional Medication Box Program- NOVA MTG and DEA updates. J. Bendit stated that G. Blake and S. Hopkins attended the last NOVA EMS/Pharmacy DEA meeting to preview potential changes in the future. G. Blake stated that they discussed similar things that the pharmacies discuss in relation to storage, inspection, acquisition, DEA Licensing, potential dispensing machines and their locations. DEA proposed changes sent to the PEMS Pharmacy Committee for review and comment. J. Bendit stated that it looks as though these proposals will help keep as much as possible the same. More to follow. It was discussed whether 3 or 4 vials should be included (for a total of either 15 or 20mg versed) once ativan is removed. 3. The primary protocols these changes affect are adult and pediatric seizure management. I have attached the DRAFT seizure protocol for reference which has not yet been voted on - I believe it needs further consideration to reflect how much Versed will be available. 4. The route of initial administration of Versed remains a concern. Most if not all studies showing efficacy of versed in seizures have looked at IM as the <u>initial</u>route, not IV. It is recommended that the initial route be IM/IN for all patients (even if they have IV access), and that IV dosing be reserved as a
