	Ketamine draft protocol – A. Balog presented his draft protocol to the committee for discussion. Discussion held regarding the fact that too many drugs in the drug box could be problematic as could having too many options for pain control. Suggestion made by B. Beam to consider rolling out Ketamine as a P only drug similar to the RSI roll out to have a better chance of it being a successful protocol. Will forward all Ketamine info to P. Hoyle to add to pharmacy committee agenda. Suggestion also made to have a max dose listed. A. Balog to add maximum dose recommendations to protocol for pharmacy committee to review. 	BLS cessation of resuscitation – M. Player reported that the state of VA dictates this is out of Scope of Practice for BLS providers. Discussion held regarding prolonged BLS run codes and request made by S. Messina to add to the current protocols a timeline for when to transport a coding pt with no ALS on scene. P. Hoyle advised the current cardiac arrest protocols have a PEARL under them that state transport should not be delayed to wait on the arrival of ALS - committee decided this is an agency issue and agencies having these issues need to consider the need for additional training for their providers.
