Staff Report	<p>PEMS report given by J. Bendit as follows:</p> <ol style="list-style-type: none"> 1) Heartsaver Hero online has a recognition website for AHA to recognize heroes. See website to recommend hero that may have been involved in saving a life performing CPR. https://volunteer.heart.org/aps/forms/pages/heartsaver-hero.aspx 2) RSAF Grant cycle began August 1, 2016. PEMS is having a representative come to the Jeannie Dunston Room at PEMS on 8-30-16 at 7:00 pm in order to review changes in the requests. 3) November 9-13, 2016 is the 37th Annual Virginia EMS Symposium. 		
Old Business	<ol style="list-style-type: none"> 1) Group reviewed the current STEMI Protocol and made several suggested changes that should be presented to the MAC in June. The requested changes are included as an addendum to these minutes. Discussion with regard to whether or not we need to submit our changes to PPP for approval. Per M. Player, any requested changes are sent to the PPP out of courtesy. Their approval is NOT needed for submission to the MAC, but our protocol should be sent along with all the others. D. Thomas will facilitate communication and submission of our protocol changes (which are minor) to the PPP. 2) J. Laing suggests that we should encourage providers to take advantage of opportunities to observe in the area's cath labs. S. Ferguson states SCH's lab is open if anyone wants to come. D. Thomas will work on creating a CE program and sign up roster to distribute interested providers between the area's cath labs that are willing to accept them as observers. 3) Joint Task Force initiatives on hold according to S. New Business	<ol style="list-style-type: none"> 1) ECG & data transmission problems. T. McGregor states that the Northern Neck has had ongoing issues with transmission of ECG & data to hospitals. This topic discussed at length without resolve for rural agencies at this point. There are several different ECG machines in use by agencies in the PEMS Region. About 20 years ago, a grant was given to the PEMS region to purchase Lifenet licenses. T. McGregor states that there is better universal means to purchase for hospitals in order to receive these different signals. He states that these vendors can use cellular devices in order to communicate between the agencies and the hospitals. T. McGregor states that there is a high cost. He recommends the Stemi Task Force provide expectations to the PEMS EOC in order to work out a way to finance something. <p>K. Harper stated that G. Hunter, Sadie Thurman, and her have been working on this for a while and that the different ECG monitors have issues with IT in supporting them.</p> <p>T. Mitchel states that ECG transmission is a State level priority. A UVA physician is championing working with rural agencies and agrees that we need a regional support in order to facilitate a regional fix for multiple types of ECG monitors and their transmission to area hospitals. He states that we need to Identify gap of what agencies can't transmit, which monitors can't transmit, and which hospitals can't receive. T.
