Staff Report	R. Blymyer advises the MAC will be voting on all draft protocols tonight, the only protocols affecting the TTF is the burn protocol that does meet the Trauma Triage guidelines.		
Old Business	L. Miller states that the State Trauma Triage Committee will have a report coming out soon with regard to over and under triage in the Peninsulas region. Cannot officially release the details at this point. Advises that the report should be out by the next PI committee meeting in October and that there may need to be a called meeting to discuss the findings of the report once it is published.  PEMS has received none of the data that the TTF requested following the last meeting. T. Mitchell suggests trying other sources of data such as the CDC. L. Miller advises that the report with 2014 data is due out anytime now and the report with 2015 data should be out by December. All members in agreement that they will wait for the state's report until December then consider other sources of data if the report is not published by then. Suggestion made to reach out to smaller agencies that may need assistance with PI and quality assurance. T. McGregor suggests forwarding that concern to the EOC for discussion.	Talk to J. Bendit	R.
