Staff Report	<p>D. Thomas reported on great attendance for EMS Day at Busch Gardens and congratulated all regional winners who will go on to represent PEMS as nominees for the Governor’s Awards. She also notes and congratulates the Hampton Roads Trauma Symposium committee from PEMS, Riverside, Sentara &amp; Mary Immaculate Hospitals for their special award recognizing 27 successful years coordinating and offering the annual symposium.</p> <p>D. Thomas presents the new <i>minimum</i> representatives for the Trauma Task Force to be identified in the Committee Bylaws for PEM to be approved by the Board of Directors at their next meeting. We can have as many <i>extra</i> representatives as we desire, but the by-laws will only list the minimums which insures we stay in compliance with the by-laws and OEMS rules for the council. The task force members in attendance reviewed changes to the bylaws and suggested some changes in verbiage to the Executive Director but approved of the minimum representatives designated. L. Miller states she will get us a Trauma Surgeon to participate on the task force.</p> <p>D. Thomas reports that she has had difficulty obtaining OEMS data in a manner that insures it is accurate for reporting purposes. Many duplicates, etc. She has requested that OEMS provide assistance.</p>		
Old Business	<p>L. Miller brought 9 boxes of Trauma Triage Cards to be given to all EMS providers in the region. PEMS will provide to the EOC for distribution and place a notice on our website for agency representatives to pick up. The Hampton Roads Trauma Symposium was held last month and was a great success.</p>		
New Business	<p>L. Miller reports that there was no TPIC data available because Dwight Crews has left the Office of EMS and he was the primary person doing that research/data abstraction. She states they were told it could be awhile before OEMS gets back up to speed in that regard.</p> <p>Discussion surrounding possible under-triage of trauma patients on Northern Neck. Disagreement amongst some on the task force, that there is a true <i>under</i> triage problem, based on our previous data which showed that the EMS providers appear to be doing the right things at the right times. Not sure how to address the true problem, which is the <i>inability</i> to get major trauma patients to a trauma center as quickly as would be desired simply due to geography or weather if HEMS cannot fly. T. McGregor thinks we should start considering the ability to administer blood products in those areas. Lengthy discussion re: feasibility. D. Belvin states he will research other east coast agencies currently using blood products in the field. He states Camden, NJ is doing it.</p>	Research & Report on Agencies using Blood Products	David Belvin by next meeting.
