| Staff Reports     | S. Craig reported that PIC is on target to meet Contract Deliverables. Thanks to everyone for their efforts in improving EMS in the PEMS Region. PEMS hired 2 part time positions. T. Veach to replace J. Bendit and G. Bever, new IT position.   |   |  |
| Old Business      | <p>Committee agreed that a survey should be distributed, probably quarterly, to see if there are system-wide trends in the region that need to be corrected. Topics may include STEMI/ECG Acquisition, Sepsis data, Safety Benchmarks/Med Errors, Trauma- over/under triage, equipment issues, etc.</p> <p>During today's meeting, the Committee discussed the acquisition of accurate data. In the past when reviewing data, for example, for a stroke patient the R.A.C.E. Score would not populate in the data for OEMS, but was present in the Patient Care Report.</p> <p>G. Samuels reported that different agencies within the region still use different stroke scales such as VAN and BEFAST.</p> <p>It was decided that once the migration to ESO is complete, we will start looking at data and specific data points. Committee Members will send top 5 data points to look at for Stroke, STEMI, and Trauma by August 1<sup>st</sup>, 2021. S. Craig will send the current list of required data points from OEMS and share with the Committee.</p> | <p>Send OEMS data link to Committee</p> <p>Reply top 5 data sets to follow.</p> | <p>S. | New Business      | E. Erwin reported that several ED doctors would like early notification from EMS providers when they are bringing a STEMI or stroke patient. Unfortunately, the time of EMS to receiving ED is not captured in the PCR, and would require hospital staff and EMS staff to compile the data. G. Samuels recommended regional training regarding using the COR vs HEAR and not waiting to call the hospital. E. Erwin emphasized that time is very important if they have to call in staff for a specific type of patient (ie stroke, STEMI, etc).  |   |  |
