Approval of Minutes	There was not a quorum from the May 14 th , 2020 present in June to approve the minutes, so those who were present at the May meeting emailed their approval. There was not a quorum from the June meeting present in July, so June minutes were not approved during this meeting. Minutes for June 10, 2020 Meeting were approved 7-12-20 via email from those who had attending the respective meeting. The Committee Minutes from June 10, 2020 were approved unanimously. T. Balog made a motion to approve the July 8 th , 2020 minutes with the correction that comments about the COR numbers added to the Protocol App were made at a previous meeting, not the July meeting. M. Doak seconded the motion to approve the minutes with that change. The minutes were approved unanimously.

	M. Doak made a motion seconded by D. Justis to propose to the MAC a shorter protocol turn-around time (twice a year instead of once a year). The Committee discussed the importance of protocol training/support during roll-outs and consideration of those agencies who still print copies of protocols. The motion was approved unanimously. 	Due to the very short half-life of Ativan causing significant medication wastage and excessive burden on pharmacies and EMS personnel regarding PEMS Medication Box exchanges, the PPP Committee voted to list Versed as the primary medication in respective protocols and change the protocols to read "if Versed is not available, administer Ativan" and include the dosing.	Update protocols containing Versed/Ativan and send out to PPP	S. Craig/8-19-20
New Business	General-Trauma, General-Hemorrhage Control, Injury-Crush, and Injury-Burn protocol changes developed by the PEMS Trauma Committee were presented to the PPP. All protocols changes were approved. M. Doak emphasized the importance of training on Permissive Hypotension when the protocols are released. General-Universal Care Protocol was approved with the change to "consider obtaining blood glucose level and temperature." Injury-Bites and Envenomation-Marine protocol was updated based on current peer-reviewed literature and research, indicating vinegar and heat are best for all jellyfish stings. OB/GYN-Eclampsia was changed to administer Versed first in Eclampsia, if refractory, administer Mag Sulfate. Medical-Seizure protocol was changed to increase the dosage of Versed from 2 mg to 2.5-5 mg IV/IO/IN, and 10 mg IM.	Present Changes to MAC	D. Justis/9-10-20
