AcidRemap, the app vendor has the updated the mobile app. The protocol tests have been completed and sent out to PEMS OMDs with Protocol Test Requests on file on March 3, 2023.

6. Old Business	 a. Protocol Review Request- Post ROSC Care, V-Fib, Pulseless V-tach and Amiodarone- The discussion from last month will be presented to MAC on 3/09/23. b. S. Craig revised the <i>Transportation & Destination Determination</i> Protocol as discussed at the January PPP meeting. In January, the Committee agreed that a free-standing ED can be an appropriate destination in PEMS and that destinations should not only be a "hospital." In addition, the Committee agreed to revise the protocol to remove the word "hospital" and add an additional line 5 to state "if locally approved alternate destinations may be established such as urgent cares or physician offices." It was emailed to the Committee and put into MS Teams, but not many people reviewed it. Discussion tabled until next month. c. Whole Blood Protocols- will be shared with the MAC on 3/09/23. A. Louka shared a recent JCC case where the patient received blood in the prehospital setting after being shot several times. By the time he arrived at the ED he was alert and coherent. 7. New Business	 a. Protocol Review Request- Transcutaneous Pacing; Adult Bradycardia. The Committee voted to set the pacing at 70 across the protocols. b. Protocol Review Request- Allergic Reaction- currently does not allow EMT to administer Albuterol and Atrovent. Committee voted to change protocol to allow EMT to administer A/A for wheezing due to allergic reaction c. Protocol Review Request- a request was asked to exam the fluid bolus amount and consider increasing form 20 ml/kg to 30 ml/kg to reflect national standards. Committee did not vote to change, but keep bolus uniform across the protocol due to simplicity in uniformity and concern about excessive fluid administration in CHF, pulmonary edema, etc. d. Titles for Adult Behavioral Emergency Protocol and Pediatric Behavioral Emergency protocol to not match. e. Protocol Review Request- indicated that IN administration of versed was omitted. Submitter was informed that it was intentionally removed due to the unpredictable bioavailability as reflected in a previous study. f. A. Louka asked about removing the [I] for peripheral vasopressors. Committee agreed, especially in light of no new EMT-Intermediates are being created, so those in the field have several years of experience, more than a first year paramedic.
